- Pay attention to audience, the professional expectations and attitude of the targeted decision makers, and the structure and flow of paper argument.
- Define the problem or issue. Highlight the urgency and state significant findings for the problem based on the data. Objectivity is a priority without overstate.
- Analyze the data, not only presenting of data. Reach the findings or recommendations through analysis of qualitative or quantitative data.
- Draw conclusions that make sense of the data and not to misrepresent it. Data should be replicable.
- Summarize findings and produce recommendations. Specific recommendations and findings should be provided in response to specific problems and avoiding generalizations.
- Generate criteria for evaluating data and information, explain the key assumptions and methodology underlying the analysis, and prioritize the criteria to assess evidence.
- Develop a theory of change and analyze the options and alternatives according to methodology and assess
 their feasibility. Illustrate pros and cons. Judge which is feasible. Include the predictable outcomes. Develop a
