APLA is an association that forms a comprehensive framework, which holds all the Palestinian local authorities and works for and with them, to provide better services for the Palestinian citizen by defending their rights, and representing them on all levels nationally, regionally, and internationally.

APLA is implementing the project (APLA's Multiannual Action Plan - (MAAP) 2021-2025), largely financed by the European Union upon signing a grant contract on 12 December 2021 with total EU contribution of € 1.9 million. This project has been designed to strengthen LGUs collaborations on service delivery and local participatory development, and improve contributions to territorial integration, particularly in Area C. Specific objectives of MAAP aim at supporting the role of APLA as LGUs representative and dialogue partner with the Palestinian Authority, to support the role of the LGUs in the building process of future State of Palestine and to strengthen the institutional and operational capacities of APLA.

empower and enhance the VCs -especially in area (C)- in their authority on land use and building, in addition to revenue generation.

The main benchmarks of the paper are:

- Strategic Roadmap:

Construct a well-defined and actionable roadmap that outlines the steps and practices required to form a sustainable Joint Regulatory and Building committee -JRBC, for village councils, especially in area C, within LGUs.

- Lobbying Effectiveness:

Devise a well-defined blueprint for influential lobbying endeavors, equipping LGUs to well utilize of legislations, policies, and regulations that bolster Joint Local Committees and optimal practices.

- Capacity Building:

Devise comprehensive guidelines and resources, in addition to in-depth exploration of relevant local government laws, procedures, and manuals that facilitate capacity building initiatives within LGUs. These resources will contribute to the development of a skilled and empowered workforce with valuable insights and knowledge pertinent to their roles in construction and urban planning initiatives.

- Foresight revenues:

The Joint Local Committees will have financial independence and management in accordance with Local Authorities Law No. (1) of 1997 and its amendments. This enables the Joint Local Committees to determine the share of each member from building fees, regulation fees, and the financial framework for transfers between the local authorities that hold membership in the Joint Committee for Regulatory & Building.

Synergistic Collaboration:

Create frameworks to cultivate collaboration and partnerships in-between the LGUs themselves.

- Promoting transparent governance and community participation:

Providing the necessary knowledge and tools to enhance transparent governance and community participation in decision-making and implementation of urban planning.

2. Main Objectives of the assignment:

To prepare, develop, and deliver a research/study paper "Establishing of Joint Committees -in particular, Regulatory and Building Committees for Village Councils", as a comprehensive tool to empower and enhance Local Government Units (LGUs) especially Village Councils (VCs) in area (C) in Palestine in their authority on land use and building, in addition to revenue generation. The output is expected to be a comprehensive tool to help Village Councils (VCs) in Palestine in better organizational and financial management, which incorporates rooting of evidence-based thinking, approaches to diversification and expansion of managerial and financial aspects of VCs through Joint Local Committees in urban planning, regulatory, and building.

3. Specific objectives of the assignment

- 1. Prepare a summary of the local government and LGUs context in Palestine.
- 2. Review of local organizing and building legislations, including in-force and other imposed by legislation on local authorities that they are required to enforce.
- Identify mandated revenues generated from legislations related to organizing and building, that are not enforced or not
 effectively enforced, by LGUs that may remain entirely frozen.
- 4. Provide guidance and recommendations for optimizing the available revenue sources for Joint Local Committee organizing and building.





- 5. Identify resources required to enforce organizing and building legislations, and how to reach these resources.
- 6. Study the formed and currently running Joint Regulatory and Buildings Committees (JRBCs) and the dissolved ones.
- 7. Understand the drivers behind the formation and dissolving of each JRBC.
- Recommend a strategy of application of the best methods to form a sustainable JRBC for a selected cluster of village councils.
- Set up a list of recommendations on the possible strategies and plans to alter and improve the enabling environment of the formed JRBC in Palestine.

4. Language:

All deliverables (research/study paper on "Establishing of Joint Committees -in particular, Regulatory and Building Committees for Village Councils" should be submitted in Arabic and translated into English after APLA's approval of the Arabic version.

5. Timeframe

The duration of the assignment is 2 months starting from 10th Oct. 2023 till 9th Dec. 2023.
